How can we expand the role the County's schools play in the support of a healthy local food system and the success of local agriculture? Do you support a rural schools' policy that provides equity for Reserve cluster schools acknowledging the unique nature of schools in region set aside for farmland and open space preservation?

The Montgomery County Public Schools should be encouraged to purchase food from our County's farms. All of Montgomery County Public Schools, whether rural, suburban or urban, should have equitable treatment.

Currently the County is exploring how best to support a strong agricultural economy through agritourism and new farming enterprises such as on farm breweries and wineries. What are your thoughts about how best to advance on farm activities within the context of the master plan?

Since Washington, DC attracts millions of tourists, agritourism would be an ideal way to support Montgomery County's farms.

What are your regional transportation priorities? Do you support M83 and an additional Potomac bridge and outer beltway through the Reserve or adjacent rural zones?

First, we need to fix Metro by transferring MetroBus, MetroAccess, Metro's parking lots and Metro's parking garages to the local governments. Metro should be limited to fixing and operating MetroRail. Second, we need to stop the \$1 billion, 100 miles Bus Rapid Transit (BRT) program. Instead, I have proposed a Bus Lane Toll (BLT) program that would convert the left lane on 3 lane roads and 4 lane roads to a reasonable variable toll lane during rush hours. The BLT would be paid from the tolls -- not by taxpayer funds; and the BLT can be quickly implemented. Also, some of the tolls can be used to reduce the bus fares during rush hours.

Third, to encourage local and commuter bus ridership, I have proposed the construction of Bus Rider Buildings (BRB) at the MetroRail stations in Montgomery County. The BRB is like a Starbucks or Dunkin Donuts, but expanded to seat at least 100 people. Thus, when waiting for a bus, the bus riders wait in a safe and comfortable building.
